Cancellation Notice by Organizer:

- 100% of the total Fees Paid or payable by the Exhibitor where either the Exhibitor does not provide any Cancellation Notice or where the Cancellation Notice is received by the Organizer on or after the date which falls 120 days before the start of the Exhibition.
- The Exhibitor shall pay the applicable cancellation charges within 30 days of the date Exhibitor's Cancellation Notice or within 14 days of the Organizer's invoice for such sums, whichever is the sooner.
